

Treasurer's Report for 2014/15

This year's accounts are pretty straightforward and hopefully self-explanatory.

There have been no exceptional items, so this year shows a pretty good idea of where we stand.

As I mentioned last year, approximately half the NCA income is from the clubs via League & Affiliation fees, while half is from the two tournaments.

The cost of the tournament venues is due to rise over the coming years. This may eat into the profits, although there is still scope to increase entry fees marginally to offset this.

I believe the current reserves are about where they should be maintained and propose that we keep the Affiliation and League Entry fees at the current level of £15.
